1. IDENTIFICATION

The Annual Implementation Report (AIR) is drawn up in accordance with the provisions under Article 112 of the Commission Regulation № 718/2007.

The current report is the sixth AIR for the Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme, CCI Number 2007CB16IPO007 (hereinafter referred to as the Programme) and spans over the period of 1 January 2014 till 31 December 2014.

The Managing Authority (MA) for the Programme is the Ministry of Regional Development and Public Works (MRDPW) of Bulgaria having as counterpart the Ministry of Local Self-government of the former Yugoslav Republic of Macedonia, acting as the programme's National Authority (NA).

2. OVERVIEW OF THE IMPLEMENTATION OF THE PROGRAMME

The Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme was approved by the European Commission with Decision C(2007) 6298 on 14 December 2007, amended with Decision C(2010) 3880 on 21 June 2010, Decision C(2012) 4936 on 17 July 2012 and Decision C(2012) 8373 on 14 November 2012 and Decision C(2014) 1536 on 12 March 2014. The description of management and control systems was approved by the European Commission with letter ref. No DG REGIO E1 D (2010), Ares 978794 / 21 December 2010.

Within the period till 31 December 2014 three open Calls for Proposals were launched under the Programme which attracted a total number of 320 applications. These figures are positive sign for the dynamics of the bilateral co-operation between the two neighbouring countries and show intensity of cooperation at the stage of project preparation. At the same time, the big number of common project proposals shows good will and increased interest in implementing joint cross-border initiatives contributing to the sustainable development and the improvement of the quality of life in the region.

The number of joint projects supported under the Programme as of 31 December 2014 is 100 (32 projects under the first Call for Proposals, 32 ones under the second Call for Proposals and 36, under the third Call for Proposals), every one involving 2 or 3 project partners. The total number of legal entities involved in project implementation is 221 among which: municipalities, district administrations, non-for-profit organisations, cultural and education institutions, chambers of commerce, etc. The financed projects cover variety of thematic issues including improving small-scale public infrastructure, protecting the environment, investing in education and knowledge sharing, strengthening research and innovation, enhancing cultural exchange, promoting local and regional governance, etc. Projects under the Programme are usually relatively small in budget but create valuable cross-border partnership, influence territorial cohesion, contribute for sharing the European values and facilitating integration.


Cross-cutting issues are addressed in the programme through the implementation of specific actions (within the financed projects) contributing to the promotion of equality between men and women; environmental protection, as well as concrete actions to promote equal opportunities and prevent any discrimination.

2.1. ACHIEVEMENT AND ANALYSIS OF THE PROGRESS

Given that the programme is now at the final stage of its implementation with an important part of the IPA funding committed to projects, it is appropriate to continue the reflection process initiated through the programme mid-term evaluation by giving answer to the following questions:

What was the programme initially meant to achieve?

The overall objective of the Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme 2007 – 2013 aims to contribute for a sustainable development in the border region in support of the wider European co-operation and integration efforts thus providing a balanced and sustainable development throughout the entire cross-border region.

The specific objectives of the Programme strategy: 1) to foster the sustainable economic growth in the cross-border region; 2) to promote social cohesion and cross-border co-operation, and 3) to further develop the attractiveness and quality of life in the cross-border area through protection and sustainable use of natural and cultural resources as well as development of tourism, were jointly elaborated by the two partnering countries on the basis of territorial and SWOT analyses, regional consultations and lessons learned from the cross-border activities implemented until 2006.

The programme strategy and its objectives fit the relevant EU and national cohesion policy promoting good neighbourhood relations fostering stability, security and prosperity in the mutual interest of both countries.

Taking into consideration the limited budget (EUR 19 944 697) and nature of the Programme, it intended to complement the strategies and measures at national level. Mainly small-scale projects were foreseen to be financed for the benefit of a larger number of applicants in different spheres of intervention.

In addition, as an IPA CBC Programme, it initially intended to provide assistance to the former Yugoslav Republic of Macedonia in terms of building institutional capacity for management of Structural Instruments in view of forthcoming EU membership.

Is the programme still on track for the achievement of these objectives and where do efforts need to be refocused?

In September 2013, the Programme's mid-term evaluation came to the conclusion that the Programme had remained relevant to the needs of the target region and even at that particular moment most of the results had been achieved. The Programme was considered as being in line and consistent with the policy context of 2014 in terms of objectives and priorities and focusing on economic growth and labour market interventions which was assessed as fully relevant to the recessionary environment of the region.

Until 31 December 2014, the majority of Programme result indicators' targets set for 2016 have been overachieved which provides a reasonable assurance that the Programme is on a good track for achieving the objectives initially set and there is no need to refocus them. In addition, the foreseen values of the Programme result indicators for 2015 and 2016 show that after finalisation of the second- and third-call projects, all targets are going to be met.

What has changed in the programme area and for the people living there as a result of the Programme's interventions?

The main results of the Programme achieved so far are:

- *Increased cross-border interaction and mobility* through establishment of new partnerships and relations between neighbours across the border - through implementation of joint cooperation projects in different thematic fields, 29 training places created, 90 joint cultural events carried out, 96 awareness-raising campaigns organised and 1630 people participating in training events among which 406 are from vulnerable groups. Networking structures or permanent networks created by the Programme are 38 and the majority of partnerships created are further developed and maintained.
- *Better preserved natural resources and biodiversity* as well as decreased level of pollution in the region as a result of 12 permanent networks for environment protection and reasonable utilisation of resources set up, 8 joint environmental management plans developed, etc.
- *Enhanced sustainable economic development* of the border region and increased competitiveness of small and medium enterprises (SMEs) by establishing joint information services and encouraging contacts across the border - illustrated by 2309 business and educational linkages created, improved

access to and usage of new technology, 7033 SMEs involved/addressed in cross-border projects, 104 new jobs created, of which 35 are for young people, 43 management and job-related training courses carried out, etc.

- Strengthened potential for development of tourism through sustainable use of natural resources and cultural assets of the border region - 66 tourist destinations developed, 56 tourist services created, of which 12 joint tourist services, 48 surrounding areas of cultural spots improved, 19 joint eco-itineraries created, etc.
- Improved / developed early warning and risk management systems as a result of 14 partnerships for cases of natural disasters created.
- Increased governance capacity and improved policies through joint initiatives, development of joint strategic documents and exchange of best practices and know-how. 35 projects were contracted under the first Call for Proposals in total amount of EUR 6,367,922.62, of which 3 subsidy contracts (with ref. numbers: 2007CB161PO007-2009-1-33, 2007CB161PO007-2009-1-34 and 2007CB161-PO007-2009-1-76) were terminated due to withdrawal of project partners. In 2014 all first call projects were successfully finalised. Information on the financial implementation of the first call projects is presented in the table below.

Under the first Call for Proposals, the total amount of EUR 132 078 was paid as interim and final payments under Priority Axis 1. The amount of EUR 30 849 was verified to beneficiaries under Priority Axis 2. As a result, total interim and final payments under Priority Axes 1 and 2 amounted to EUR 162 927. No advance payments were made in 2014.

33 projects were contracted under the second Call for Proposals in the total amount of EUR 8 203 692.72 with financial allocation for 2010, 2011 and 2012. 1 subsidy contract with reference number 2007CB16IPO007-2011-2-62 was terminated for preventing the possibility of double financing occurrence.

14 investment projects in total amount of EUR 5 130 473 and 7 soft projects in total amount of EUR 663 536 successfully completed their implementation in 2014. The final monitoring visits have shown that all beneficiaries have fulfilled foreseen activities, planned targets and indicators in accordance with the subsidy contracts.

As a result of analysis of the financial implementation on the programme on 3 June 2014 the JMC took a decision for overcontracting additional projects with generated savings from the completed projects under priority axes 1 and 2 and the expected savings based on the average absorption rate on Programme level.

Pursuant to the JMC decision, 9 additional subsidy contracts were concluded during the second half of 2014.

10 soft projects in total amount of EUR 843 868 successfully completed their implementation in December 2014. The final monitoring visits showed that all beneficiaries had fulfilled the foreseen activities, planned targets and indicators in accordance with the subsidy contracts. Information on the financial implementation of the third call projects is presented in the table below.

Under the third Call for proposals, 5 new subsidy contracts under Priority Axis 1 were signed at the total budget amount of EUR 729 683. Thus, a 29% increase of the number of contracts leads to 35% increase of their total value. Under Priority Axis 2, 4 new subsidy contracts were signed at the amount of EUR 1,171,286. The elasticity is even larger, as a 40% increase of number of contracts results in 59% of total budget value.







As it can be seen, all regions have been active in the process of developing and implementation of projects, whereby a balanced coverage of financial resources is achieved in the whole eligible area. The cross-border character of implementation of the projects is evident in the constant and active communication and

exchange of information between the project partners in terms of developing: Detailed action plans of the projects; Project procurement plans; Project progress reports; Implementation of joint activities. A lot of partnership relations have been created or prolonged during implementation of joint projects, large number of meetings, seminars, conferences or similar events have been organised.

- **Modifications of the subsidy contracts**

During the project life-cycle, due to the certain reasons, the following types of modifications in the subsidy contract concerning the project implementation have been requested by the beneficiaries:

1. Modifications requesting notification to the MA and approval by the JTS;
2. Modifications requesting approval by the MA;
3. Modifications requesting approval by the JMC and signature of Addendum.

The requested minor modifications by the beneficiaries during year 2014 related to prior notification to MA and approval by the JTS were related to changes concerning the project's content (modifications of the approved Application form related to change of the project action plan as well as minor changes in activities). The approval was given together with approval of the respective Progress Report.

The following types of modifications needed written approval by the MA were requested by the beneficiaries:

- Budget changes - modification related to budget reallocation between budget lines in the limit of 10% and modification related to budget reallocation between budget sub-lines. Inclusion of VAT in the separate budget line is another budget change approved by MA;
- Use of "Contingency" budget line are frequently requested for additional activities / quantities resulted by unfavourable or emergency situations which could not be foreseen at the stage of the investment planning;
- Changes in project team are the most frequently requested modification during project implementation. Great number of project members had been replaced in the beginning and during projects' implementation. In order to meet the criteria for replacement, the newly-proposed project members had to demonstrate the qualifications and competences relevant to the ones the members proposed for replacement had.

Substantial changes of the Subsidy contracts have been subject to approval by the Joint Monitoring Committee and signature of addenda. In 2014 these were modifications concerning:

- Extension of the project implementation period, and
- Inclusion of applicant's own contribution.

Addenda for extension of implementation periods to 1 (one) project under the third Call for Proposals have been concluded with prior approval by JMC. The request for extension of implementation period is related to

delay in projects implementation due slowdown in the reimbursement of expenditures caused by irregular transferring of the nation co-financing.

Addenda for inclusion of additional (applicant's) co-financing were signed with 1 (one) project from the second Call for Proposals and 2 (two) projects from the third Call for Proposals with prior approval by JMC. The requests for inclusion of additional co-financing are connected to the discrepancies between the amounts envisaged in budgets and the offers received in the works/supply tender procedures.

Modifications concerning the administrative part of the project (change of bank account, contact details, address for communication) have been made by notification to MA.

In compliance with the recommendations of DG REGIO, EC (Letter ARES (2015) 424874), the values of the result indicators for the years 2011, 2012, 2013 and 2014 are based on finalised projects. The values of Programme's result indicators for 2013 are calculated on the basis of finalised first and second call projects, while those for 2014, on the finalised second and third calls' projects. Data on the forecasted achievement in 2015 and 2016 are based on the implemented and not finalised contracts under the second and third Calls for Proposals.

To assess the real achievement of the expected results, the sum of indicators' values for 2011, 2012, 2013 and 2014 was compared to 2016 target value.

From the data in the table it is apparent that most of the result indicators have reached their target values close to or considerably above 100% by the end of 2014. The expectations are that most of the Programme's result indicators will be reached after second and third calls' projects finalisation.

The values of majority of Programme's result indicators in 2014 show that the Programme is on track for the achievement of its objectives, especially of those related to sustainable economic development and improvement of the quality of life through utilisation of ecological and cultural resources of the region.

Until 31 December 2014 several result indicators' targets for 2016 were overachieved, which gives us a reasonable assurance to believe that:

- Joint information services were established (RI 1);
- Projects of good quality prepared under the Programme Sphere of Intervention 1.3 were actually applied (RI 5);
- Pollution in the region was decreased (RI 6);
- Attractiveness of the region was actually increased based on preservation of natural resources and cultural heritage (RI 8).

The accumulated values of some result indicators are below the targets set for 2016 but the Programme is still on track for their achievement. The results that need more efforts to be achieved (according to their targets for 2016) are: increased cross-border movement of people and exchange of goods and services in the region (RI 2), new social economic enterprises created (RI 3), and increased common cultural capital (RI 9), however, in the case of these three specific result indicators, not only the Programme's implementation is supposed to have an influence on their values. In conclusion, all Programme's result indicators that are assignable and realistic according to the SMART criteria have already achieved their targets.

The table above represents data for the programming period 2007-2013 according to the approved by the JMC on 12 October 2011 amendment related to new financial allocations covering the period 2012 and 2013 of the Programme which follows the adoption by the EC of the Multi-annual Indicative Financial Framework 2012-2013 and approved Programme amendment related to the de-commitment procedure for 2011 (Decision C (2012) 8373 on 14 November 2012).

- Achievement of Programme payment targets (n+3 rule)**

All the measures taken by the MA for speeding up the verification process such as possibility for additional verifications of expenditures, training for beneficiaries, individual consultations, etc. resulted in a higher level of absorption of the funds by the project partners during 2014 over the target. The spending targets of the Programme were met: while the amount that had to be certified during 2014 was EUR 2 799 216 (IPA financing), the total amount of the IPA funds certified to 31 December 2014 was EUR 4 083 360.

The goal for 2014 is overachieved with EUR 1 284 144 (IPA funding) and there is no loss of funds. This was result of the combined efforts of the MA and JTS (both main and branch offices) that palyed a proactive role in the smooth projects' implementation by providing individual consultations, publishing additional guidance and templates of the most frequently used project documents, tender dossiers and day-to-day communication in support to the project partners.

Data from quality check performed by the Certifying Authority

During 2014 the "National Fund" Directorate at the Ministry of Finance of the Republic of Bulgaria, acting as Certifying Authority (CA) for the Programme has conducted a regular on-the-spot check before certification.

As a result of the common efforts of the joint management structures – MA, NA and JTS four certification report were submitted to CA in 2014 amounting at EUR 4 083 360 (IPA funding). Based on the results from on-the spot checks, desk-based checks of the submitted MA's reports on certification, as well as on assessment of other available information by the Certifying Authority, the total amount of EUR 4 083 360 (IPA funding) is proposed for certification to EC by the CA.

2.1.4. Information about the breakdown of use of the funds

During 2014 the project beneficiaries submitted to the MA requests for interim and final payments amounting to EUR 3 421 555 for the implementation of projects under priority axes 1 and 2. Payment claims related to Technical Assistance Priority Axis amount to EUR 110 956.

2.1.5. Assistance by target groups


The usual beneficiaries and target groups of the Programme are local and regional authorities and their associations, regional structures of central public authorities, regional and sectoral development agencies, non-government, non-profit organisations, research, cultural and education institutions, business support organisations, etc. Frequency of project partners among different target groups shows the following

distribution: 5 cultural institutions, 7 chambers of commerce, 10 public bodies, 17 educational institutions, 81 municipalities and 101 non-governmental organisations took part in cross-border cooperation projects.



Citizens and governments of the two countries benefitted from the implementation of the Programme. Indirectly, the Programme had an added value for the inhabitants of the cross-border region through the direct Programme investments in the region and the joint use of infrastructures, and enhanced cooperation activities in sectors such as health, culture, tourism and education. The Programme contributed also to the assistance, which the IPA provided to the former Yugoslav Republic of Macedonia in their progressive alignment with the standards and policies of the European Union in view of forthcoming EU membership. Benefits for the former Yugoslav Republic of Macedonia were tangible in terms of building institutional capacity for the management of Structural Instruments and other forms of EU Assistance in the future. As regards the direct advantages for the former Yugoslav Republic of Macedonia (in light of EU accession), the Programme facilitated the transition to the EU practices on a multi-level basis (becoming more familiar with the use of the instruments in place for implementing mainstream EU interventions, the transfer of know-how between Programme implementing structures, etc.).

2.1.7. Qualitative analysis

Towards the end of 2014, 100 projects of a total amount of EUR 20 222 470 were contracted under the Programme. The projects under Priority Axes 1 and 2 were selected in three Calls for Proposals: two open Calls for Proposals (with 32 and 32 projects supported respectively) and one targeted Call for Proposals (with 36 projects supported). All first call projects, 21 second call projects and 10 third call projects have successfully completed their implementation by the end of 2014. 36 projects are still being under implementation.

Frequency of occurrence of project partners divided by target groups shows the following distribution: 5 cultural institutions, 7 chambers of commerce, 10 public bodies, 17 educational institutions, 81 municipalities and 101 non-government organisations.

During 2014 efforts were concentrated on ensuring a sufficient speed of Programme implementation and raising awareness about projects achievements and benefits. Considerable progress in the Programme financial implementation was observed in 2014. The Programme achieved and exceeded its financial goal, thus no funds were lost due to automatic decommitment rule (N+3). The Programme payment target for 2014 amounting to EUR 2 799 216 (IPA financing) was overachieved by EUR 1 284 144 and there was no loss of funds.

As of 31 December 2014, the total contracting amount for projects under Priority Axes 1 and 2 was EUR 20 222 470 or more than 113% of the available budget, and almost 68% of the total contracting amount were paid to beneficiaries. The total contracting amount for 53 projects under Priority Axis 1 was EUR 9 215 241 and the payments to beneficiaries amounted to EUR 6 052 655. The total contracting amount for 47 projects under Priority Axis 2 was EUR 11 007 229 and the payments to beneficiaries amounted to EUR 7 626 726. In addition, several projects supported by “Technical Assistance” Priority Axis were implemented.

The measures taken by the MA, NA and the JTS (both main and branch offices) such as organising training sessions for beneficiaries, providing a continuous support and advice during the project implementation, speeding up the verification process, etc. resulted in improved performance and in higher level of absorption of the Programme budget.

Similarly, the level of absorption of Programme funds was apparently increased in 2014 based on improvements in the FLC systems of the two partnering countries. Based on recommendations of audits and the mid-term evaluation performed, the MA established a pool of external independent controllers in Bulgaria, divided into groups specialised in verifications of projects under different financing Instruments (IPA or ERDF). The MA adopted a procedure for appointing controllers for the project's lifetime with regularly updated checks. As a result of the improvement of the first-level control procedures, the process from the





ANNUAL IMPLEMENTATION REPORT 2014

submission of a request for FLC verification until the reimbursement of the payment claim was accelerated and the period for its execution was shortened up to 90 days. Thus the financial control could be assessed as effective considering the overall duration of the process.

The distribution of the support by partner country is quite equitable. The supported projects have quite wide regional scope. Out of 50 eligible municipalities, projects are implemented on the territory of at least 39. According to the mid-term evaluation, 90% of the target region population benefits from the Programme's implementation. The distribution of funding by eligible target region is to a large extent proportionate to the regional population and territory.

The horizontal themes are also taken into consideration through the standard format of the application form developed by the Programme. The MA procedures for ensuring compliance and integration of the horizontal themes are in line with the established best practices. In the selection process, priority was given to projects contributing to horizontal objectives and in implementation, compliance and integration to the horizontal priorities is reported by beneficiaries and verified by the controllers and the JTS.

During 2014, no significant problems were encountered for programme implementation and no risks to programme performance were identified.

The main activities for preparation of IPA II Cross-border Co-operation Programme Bulgaria – the former Yugoslav Republic of Macedonia were implemented in 2014 with the “Technical Assistance” Priority Axis support, among which: territorial analyses, an on-line survey, two rounds of regional consultations with Programme stakeholders, draft Programme ex-ante and strategic environmental assessment, Joint Working Group meetings (in Skopje and Sofia), one technical meeting for discussing the Programme management and control systems and the draft Memorandum of Understanding for the period 2014-2020. The draft final IPA II Cross-border Co-operation Programme Bulgaria – the former Yugoslav Republic of Macedonia was approved by the governments of the two countries and was sent to the European Commission on 19 September 2014 for further proceedings. After EC official comments had been received on 3 February 2015, the revised draft of the Programme (version 2.0 of March 2015) was re-submitted to the Commission on 6 March 2015. The Programme approval is expected in June 2015.

2.2. INFORMATION ABOUT COMPLIANCE WITH COMMUNITY LAW

There are no problems encountered relating to the compliance with Community law in the implementation of the Programme.

The Programme has been prepared in accordance with Community Strategic Guidelines 2007 – 2013 priorities – especially in the area of improving of the attractiveness of the cross-border region and further developing of the human resources.

The Programme is compliant with the main EU strategic documents, notably with the Lisbon and Gothenburg strategies, targeting sustainable development, equal opportunities and cross-border partnership.

The overall strategic goal and the priority axes of the Programme are fully compliant with main Bulgarian and Macedonian national strategies and programmes, which are indicated in the Programme document. In order to ensure sound financial management of the Programme, the MA initiated a respective procedure and Decree No 222 of Council of Ministries for eligibility of expenditures was adopted on 11 September 2009.

The Memorandum of Understanding between both partnering countries for the implementation of the Programme was signed on 31 August 2010. The document lays down the general rules for the implementation and financial management of the Programme as well as defines the bodies involved in the management and control and allocation of functions (responsibilities and rights) within each body involved into the implementation of the Programme.

2.3 SIGNIFICANT PROBLEMS ENCOUNTERED AND MEASURES TAKEN TO OVERCOME THEM

No significant problems for programme implementation were encountered during 2014.

2.4 CHANGES IN THE CONTEXT OF THE PROGRAMME IMPLEMENTATION (IF RELEVANT)

The Programme document drafted jointly by the two countries through a large partnership with national, regional and local stakeholders was approved by the European Commission with Decision C(2007) 6298 on 14 December 2007, amended with Decision C(2010) 3880 on 21 June 2010, Decision C (2012) 4936 on 17.07.2012, Decision C (2012) 8373 on 14.11.2012 and Decision C (2014) 1536 on 12.03.2014. It sets out the general framework of intervention of IPA in the Programme cross-border area.

2.5 COMPLEMENTARITY WITH OTHER INSTRUMENTS

A clear demarcation and complementarity of Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme 2007-2013 is ensured with: 1) other European territorial co-operation / IPA strands – in particular, the relevant cross-border and transnational co-operation programmes; 2) other EU co-financed programmes or funds implemented at national level such as Environment, Regional Development, Development of the Competitiveness of Bulgarian Economy, Human Resources Development operational programmes and Rural Development Programme for Bulgaria, as well as IPA component III, IV and V programmes in the former Yugoslav Republic of Macedonia; 3) other programmes / projects with national / regional and other funding of each of the partnering countries.

Complementarity and co-ordination with the other financial instruments is largely maintained during each stage of Programme Cycle Management through:

- Proper composition of the Programme Joint Monitoring Committee at the stage of Programme implementation and of the Joint Working Group at the stage of IPA II CBC Programme implementation;
- Existing national / regional co-ordination structures and mechanisms in both participating countries.

For example, MA representatives take part in the Regional Development Councils / Regional Co-ordination Councils that ensure co-ordination of all the EU co-financed programmes at regional (NUTS II) level in Bulgaria. In turn, representatives of such national and regional co-ordination structures participate in the Programme JMC sessions. Another tool used in the process of exchange of information for this purpose is the Programme Management Information System where one can obtain information related to different horizontal aspects as well as information on projects contributing to the EU Strategy for the Danube Region.

Geographically, Bulgaria with its whole territory is within the target areas of the EU Strategy for the Danube Region, while the former Yugoslav Republic of Macedonia part is outside it. For the first time during programme implementation, in 2013 the mid-term evaluation made review of the activities carried out on Bulgarian territory and of the joint projects that are considered coherent with three of the pillars and seven of the priority areas of the EUSDR. For more infomation, please refer to the Evaluation Report that is available at the Programme website.

2.6 MONITORING ARRANGEMENTS

Monitoring of the Programme is focused on ensuring quality of implementation and compliance with applicable rules and procedures. The Description of management and control systems ensuring reliable accounting, monitoring and financial reporting system The European Commission issued a letter ref No DG REGIO E1 D (2010), Ares 978794/21 December 2010 with positive assessment on the Description of management and control systems of the Programme (in accordance with Article 115 and 116 of Commission Regulation (EC) No 718/2007).

- **Implementation manuals and Management Information System (MIS)**

IPA Programmes Manual

The legal basis for elaboration of the IPA Programmes Manual (PM) is, as a general rule, the EC regulations and decisions implementing the IPA and the programming documents concerning the Programme. The PM and its annexes and appendixes describe in detail the specific rules and procedures for implementation of the Programme. It has been jointly developed by the MA, NA and Joint Technical Secretariat.

In order to improve the consistency and to facilitate the implementation of management and control procedures, the Managing Authority has elaborated a common manual (IPA CBC Manual) for the three IPA CBC Programmes, managed by the Bulgaria.

The system for revisions, updates, modifications and development of the Programme Manual aims to tackle with amendments in the three IPA Programmes (where applicable), legislative modifications or unexpected socio-economic development, which has a direct impact on the implementation of the Programmes. During 2014, amendment to the IPA CBC Manual was approved in December 2014 related to optimisation of the checklist for monitoring site visit report.

Project Implementation Manual

The Project Implementation Manual (PIM) is a guiding tool prepared by the MA, NA and JTS to help the beneficiaries in the process of project management and implementation. PIM is prepared as a guide-book, which consists of several main topics, as: Legal and Institutional Framework, Contracting and contract's modifications, Project's implementation, Procurement, Financial Management and Control, Information and Publicity, Monitoring and audit of the project, etc.

During the year 2014, some amendments and clarifications were made to the PIM for the projects funded under the Second call for Proposals and its annexes, as reflected into version 5 as of June 2014. PIM for projects funded under the third Call for Proposals was also amended with version 2 as of June 2014. The amendments were caused by changes for public procurement procedures (PRAG 2014) as well as some minor changes with regard to project implementation.

The updated and improved Project implementation manuals are available at Programme's web-page: www.ipa-cbc-007.eu.

Management Information System (MIS)

In order to facilitate the overall implementation of the Programme, at both programme and project level, the Management Information System is created as practical tool for performing the task of the relevant authorities (Managing Authority, National Authority, Certifying Authority, Joint Technical Secretariat). The information system is operational and under updating its functionality. The system's scope covers all joint programme and project level tasks as follows:

- Programme and call for proposals management: the adequately recorded programme data creates the basis for all sorts of further monitoring activities. Thus programme data like priority structure, budget, indicators etc. are recorded in order to facilitate programme-level monitoring and aggregations.
- Project module: functionality of the project section ensures tracking the whole life-cycle of projects including TA projects as the system facilitates the management and monitoring of a great number of

project related tasks (contract and modification data, implementation data - management of progress reports and request for FLC, etc.).

- Financial management: the financial section is also a crucial part of the system's functionality. It ensures the sound management of Community funds.
- Reporting: in addition to the project applications and contracts data, a section for programme reporting and evaluation will be established during the current functionality's updating of the system.

Additionally in 2014 the following changes were implemented:

Patch 1.4.05111014 – Additional functionality was added for financial report management in regards to the work of the first level controllers in partnering country. Additional groups were added and control mechanics were placed to ensure proper distribution of the information flows between the parties in FLC.

- **Monitoring measures and risk assessment procedure**

Project level

The overall monitoring at projects level is carried out by the JTS for Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Co-operation Programme with main office located in Kyustendil, Bulgaria and a branch office placed in Strumica. The JTS implements the main monitoring tools – on-the-spot checks and checks of project progress reports (PPR), verifying the proper implementation of the projects in conformity with the provisions of the subsidy contract, the objectives of the approved application form and Programme rules.

During the reporting period, 34 initial monitoring meetings were held in the premises of the JTS offices. The main purpose of the initial monitoring visits is to be checked the available resources for the project implementation, to be discussed the preparedness for the tender procedures and the project implementation strategy; and to be performed the initial risk assessment, etc. During 2014, JTS managed to carry out all initial visits within the first three months of implementation, as required by the IPA Programmes Manual.

During the year 2014, on the basis of the Risk assessment analysis and Risk response plan one ad-hoc monitoring visit of the project under the second Call for Proposals has been performed by the JTS. The subject of the monitoring visit is the progress of the project to be checked in compliance with the terms and conditions set out in the implementation plan as well as the physical check of the investment activities and services delivered to be performed. During the year JTS has organised technical meetings with project beneficiaries from the second and third Calls facing delays in implementation. During these meetings it was discussed thoroughly the problematic issues as the appropriate resolving measures were formulated.

In accordance with the Annual Monitoring Working Plan, 27 final monitoring visits were performed throughout 2014.

Programme level

The Managing Authority and the Joint Monitoring Committee (JMC) are responsible for monitoring the Programme implementation in accordance with the principle of sound financial management. The Joint Monitoring Committee observes the monitoring of the Programme implementation and ensures the achievement of the Programme objectives through a rational use of the allocated resources.

During the reporting period, **one JMC meeting** was carried out on 3 June 2014 in Strumica (the former Yugoslav Republic of Macedonia). Main decisions of the JMC meeting were the approval of the Annual Implementation Report of the IPA Cross-border Co-operation Programme CCI 2007CB16IPO007 for 2013 and of the MA proposal for contracting additional projects from the reserve list under the third Call for Proposals. Additionally, **several JMC written procedures** were organised on the following dates:

13 March 2014 – written procedure concerning approval of Negotiation Report from conducted pre-contract site visits and negotiations with projects from the reserve list under Third Call for project proposals under Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme.

So that issues related to smooth programme implementation are discussed, during the period under review a number of **Joint technical meetings** between MA / NA / JTS were organised by the JTS. Issues related to the preparation of the next programming period 2014-2020 were discussed as well.

9 December 2014 – MA/NA technical meeting in Sofia, Bulgaria, concerning: the first draft of the description of functions and procedures in place for the Managing Authority (Management and Control Systems of the Programme for the period 2014-2020) and first draft of the Memorandum of Understanding for the period 2014-2020. Other questions about the new programming period were also discussed and the status and the implementation of projects of the programming period 2007-2013 were presented.

Risk assessment procedure

Risk assessment is a continuous, forward-looking process and should address issues that could endanger achievement of the planned objectives. A continuous risk management approach is applied to effectively anticipate and mitigate the risks that have critical impact on each project, as well as the cumulative effect of all risks at a programme level.

The risk assessment under the programme is carried out by a Risk Management Group (RMG) consisting of MA and JTS representatives. The main task of the RMG is to perform risk assessment through determining a baseline categorisation of potential risks events and subsequent analysis and assessment. The RMG prioritises the risks identified and provide a Risk response plan to reduce the likelihood or consequences of risk impact. The scope of the assessment covers the following main aspects:

Institutional Risks. Assessment of the project partners' technical capacity to manage the project (incl. overall project management and co-ordination by the lead partner, human resources, assignment of responsibilities, team changes, ability of the beneficiary to submit required documents, communications between the partners, partnership changes);

Operational Risks. Review and assessment of whether the performance characteristics (planning and organisation of project activities, implementation procedures in accordance with project timeschedule, project content changes and budget changes, extension or suspension of the project's implementation period, beneficiary's obligations related to the information and publicity activities under the project, achievement of the project output/result indicators, reporting of project implementation, beneficiary's response to instructions and recommendations of programme or other authorities) are in line with accepted project management practice;

Procurement Risks. Assessment of the risks related to subcontracting procedures, i.e. whether subcontracting was well defined and planned; whether the procurement processes were documented properly and the selection process was carried out objectively; and whether the procurement rules were well understood and strictly applied; risk of non-completion of tender procedures and cancellation of signed contracts;

Financial Risks. Assessment of the financial liabilities associated with the project, including operational and maintenance costs, PPs' own contribution, financial reporting (incl. unexpected / expected delays regarding the FLC and/or not properly prepared requests, slow rate of absorption of funds – total and by partners. Financial implementation depending on the type of the organisations – public authority or NGO).

A Risk Management Group (RMG) has been established with order № RD-02-14-565 as of 18 June 2013 and consists of Chairperson /representative of CBC External Borders Department/, representatives of Financial Management and Control Department and JTS in Kyustendil.

After the first risk assessment session of the RMG in January 2014 (based on the quarterly Analysis of the project progress under the second Call for Proposals elaborated by JTS and the progress reports presented) risk categories / criteria were detected in the following levels: institutional, operational, procurement and financial risk. Annexes 11.9 "Risk assessment" at project level has been prepared for the 13 risky projects. Information has been summarised within the Annex 11.10 "Summary Project Risk Assessment Report". 2 projects have been assessed as risky in the institutional risk level in the risk category "Project management and project partnership". 7 projects have been assessed as risky in the operational risk level in the following risk categories: Contract modifications; Project Implementation and reporting. 3 projects have been assessed as risky in the Procurement risk level in the risk category Sub-tendering procedures. 11 projects have been assessed as risky in the Financial risk level in the risk category Financial implementation.

Second risk assessment session of the RMG was held in April 2014. Identified 13 risky projects under the second call have been assessed on the basis of elaborated by JTS quarterly Analysis of the project progress under the Second call and presented progress reports. Elaborated Annexes 11.9 "Risk assessment at project level". The RMG proposed risk reaction and measures which determined options and actions to reduce the likelihood or consequences of risks impact on the project's objectives under the second and third calls. JTS Kyustendil carried out the actions of the risk response plan and observed the planning and organization of projects activities, timetable and outcomes in the subject of early warning about substantial delays in projects implementation or problems with achievement of the projects objectives.

Where the risks occurred the MA/JTS took the following measures to mitigate the risks impact for the projects under the second and third Calls for Proposals:

- Informing the lead partners (LP) and project partners (PP) about their risk rating by letter, facsimile;
- Requiring clarification from the LP / PP about the detected risky event/-s;
- Requiring information from the LP / PP about the measures taken to overcome the problem/-s;
- Sending letters by facsimile to LP / PP with recommendations to overcome the problem/s (letters for strengthen the management of the project activities and financial discipline; reminder letters, related with timely implementation / forthcoming finalisation of the projects);
- Discussing measures/gave statements to overcome the problem/s with the LP /PPs/ by phone (as alternative financial sources, improvement the quality of the submitted reporting documents – project progress reports (PPRs), requests for first level control (RfFLC), requests for payments (RfPs), changes in the project time schedule, extension of the project implementation period, etc.);
- Uploading questions and answers section and samples of the most frequently used documents (project progress reports; request for payments; timesheets; tender dossiers for the different types of procurement procedures) on the programme web site;

- Providing timely and individual consultation of project teams in project implementation issues (tender procedures, preparation of the PPRs, RfFLC, RfPs, etc.);
- Participating as observers in the tender opening sessions on the spot to beneficiaries;
- Organising technical meetings for beneficiaries in MA / JTS premises to discuss and avoid potential risks/problems in project implementation;
- Conducting ad hoc monitoring visits on the spot to beneficiaries.

- **First Level Control system**

In accordance with the Description of the Management and Control System, the MA implements control on the ongoing projects through first level control (FLC) system. The FLC system is developed in accordance with Art. 16 of Regulation (EC) 1080/2006 in order to make possible in the framework of the Programme to verify:

- Delivery of the products and services (as described in the approved Application Form which is the reference point for the approval decision regarding the activities and finance; and/or the project subsidy contract – which sets the legal background for the implementation of the project.);
- Soundness of the expenditure declared;
- Compliance of such expenditure with Programme, EC and national rules.

First level control exercised in Bulgaria

Bulgaria set up a decentralized control system and the same approach was adopted by the partnering country. In Bulgaria the first level control is carried out by external independent controllers selected by the DG "Territorial Cooperation Management" within the Ministry of Regional Development and Public Works in accordance with respective national rules, authorized by the ministry in its capacity of Managing Authority for the Programme.

According to the Description of the Management and Control System, control over performance of the first level controllers is at two levels:

- 100% formal cross-check of the documents presented by first level controllers;
- Quality control on a "sample basis" in percentage of the number of the controllers who have executed FLC within quarterly period. The first level controllers covered by the sample are subject to documentary and/or on-the-spot quality checks. The quality control over performance of the first level controllers is carried out by documentary check, on-the-spot checks on a sample basis and checks in result of received notice/signal for potential irregularity and/or appeals from project partners.





During the year 2014, the FLC system was duly implemented for the purposes of verification of expenditures for amounts spent by the project partners implementing projects signed under the first and the second call for proposals. Within the reporting period, the MA took measures for improvement of the system, based on the audit findings and in order to enhance effectiveness of the FLC controllers performing verifications for Bulgarian project partners. Within the established pool of external independent controllers separation depending on the type of territorial cooperation programmes for which FLC is carried out was introduced, consequently a list of "IPA specialised" first level controllers was established in order to enhance performance and facilitate them in operating with single set of rules, procurement requirements, reporting templates, etc. The possibility to avoid rotation of first level controllers who carry out verifications for single subsidy contract was considered in order to enhance effectiveness taking into account that the first level controller who is aware with the contract performing first on-the-spot visit will be in position to perform more efficient verifications on the same subsidy contract than another controller who need to get aware with the project at later stage of implementation. Consequently, the controllers included in the list for IPA programmes, were assigned to perform all verifications under the same project. In order to optimise the efficient use of resources, for the subsidy contracts under the second and third call for proposals the first level control is performed on six months periods with an option a request for FLC to be allowed on three months basis depending on the spent amounts.

Within the year 2014, 98 requests for first level of control were submitted by project partners. The chart below represents the flow of invitations to first level controllers on monthly basis for the Bulgarian side.

Confirmed invitations by first level controllers to carry out FLC for project partners of Bulgarian side in 2014







During 2014, the Bulgarian First Level Controllers encompassed 108 on-the-spot visits on the premises of respective project partners in Bulgaria which represented 55 projects.


Comparison related to intensity of the first level control workload

The confirmed invitations in 2014 for FLC for Bulgarian project partners within the programme are 98 which represents share of 33% of all controls performed under the Programme.

The summarised data related to confirmations by first level controllers for performing FLC on Bulgarian project partners under the programme show dominated share for year 2013 and 2014 in comparison with 2012 and 2011.

In terms of sufficient increase of workload the trend is positive but regarding the rhythm of financial absorption on quarterly basis, there is no sufficient level of predictability regarding the number of submitted requests for FLC on behalf of the respective lead partners implementing subsidy contracts.

First level control exercised in the former Yugoslav Republic of Macedonia

For the purpose of verification of the expenditures made by the beneficiaries, National Authority have structured First level control system. The main responsibility of the controllers is to guarantee that the costs charged under the subsidy contracts are justified and that payments claimed by the partners are in accordance with the legal and financial clauses of the subsidy contract and within the rules of the Programme, the European Union regulations and the respective national legislation. Obligation of the controllers is to signalise NA in any case of fraud suspicion and to present evidences on which the suspicion is based.

The Macedonian FLC system is decentralised. The Controllers are employed as freelance contractors with a framework contract, selected through regular calls and included in a list of Controllers for this Programme (currently 7 Controllers). The experts are recruited through a procedure carried out in line with the national legislation. In the former Yugoslav Republic of Macedonia National Authority designate a controller from the pool of contracted experts for the functions of controllers.

The designation of Controllers is done in accordance with the Methodology for Selection and Designation of Controllers. Following the procedure for selection and designation of a Controller an Engagement contract is signed for performing FLC of the projects financed under respective Call for Proposal. After a Designation Certificate is issued by the NA in Ministry of Local Self-government (MoLSG) and when the verification is done and the needed correct reports and documents are issued by the Controller in NA and after the payment is done by the MA to the LP/PP and programme officer from NA is notified by receiving Table – Register for payment, MoLSG issues a Decision for payment of the Controllers for the respective FLC period as stated in the Request for FLC.

In relation with received Request for First Level Control by e-mail from MA, in NA were issued 59 Designation Certificates for 23 projects from the Second call and 58 Designation Certificates for 31 projects from the third Call for Proposals. During 2014, the Macedonian First Level Controllers encompassed 117 on the spot visits at the premises of the project partners in the former Yugoslav Republic of Macedonia which represented 54 projects.

In the former Yugoslav Republic of Macedonia there is a possibility for rotation of first level controllers for verifications of expenditures on one single project. NA considers this as effective measure for not having to close relations between controller and project staff, in situation of late verification of expenditures of the

project and late submission of relevant documents by the controller to NA and of course, in situation of rejection by the controller to perform verification. For the subsidy contracts under the second and third Call for Proposals the first level control is performed on six months periods with an option a request for FLC to be allowed on three months basis depending on the spent amounts.

During the year 2014, the FLC system was duly implemented for the purposes of verification of expenditures for amounts spend by the project partners implementing projects signed under the Second and the Third call for proposals. Within the reporting period, the NA took measures for improvement of the system, based on the audit findings and in order to enhance effectiveness of the FLC controllers performing verifications for Macedonian project partners.

- **Audits under the Programme**

System audit

In accordance with the Annual audit plan of AEUFEA, the AA performed the fourth system audit under the Programme in the period 2 December – 31 December 2014. The system audit objective was to obtain reasonable assurance about the effective functioning of the management and control systems of the Managing Authority, National Authority, FLC system and JTS under the Programme in accordance with the requirements of Regulation (EC) 718/2007. The audit was carried out at the Managing Authority – General Directorate “Territorial Cooperation Management” at the Ministry of Regional Development of the Republic of Bulgaria and in the National Authority, Ministry of Local Self-government of the former Yugoslav Republic of Macedonia.

The audit activities were performed by joint audit team, including auditors from “Audit of European Union Funds” Executive Agency to the Minister of Finance (AEUFEA) and Audit Authority (AA) for the Instrument for Pre-accession assistance for the checks on the territory of the former Yugoslav Republic of Macedonia. The scope of the audit includes the key requirement 7 „Necessary preventive and corrective action where systemic errors are detected by the audit“, as well as follow-up of the corrective measures undertaken on the recommendations given within the third system audit and the second audit of operations. The audit team examined the respective control activities undertaken by the MA and NA during the period from 1 January 2014 to 1 November 2014.

The preliminary results of the checks of the NA, FLC system and JTS Antenna on the territory of the former Republic of Macedonia were communicated with NA's management and sent to the Audit Authority on 26 December 2014. According to the preliminary results of the checks of the AA, there are no open recommendations and the undertaken corrective measures by the NA are effectively implemented.

Based on the overall analyses carried out, the opinion of the AA states “The system works well, only minor improvements are needed”, corresponding to Grade 1.

Audit of operations

Within the 2014 the AEUFEA has conducted audit of operations for assurance that the certified expenditures are correct and the underlying transactions are legal and regular. During the audit mission expenditures certified in the period of 1 January 2013 to 31 December 2013 were checked. The AA has underlined five findings with financial impact, amounted to EUR 9 018.95, for which the relevant corrective measures have been undertaken by MA.

• **Evaluations under the Programme**

Multi-annual Evaluation Plan for the Programme was elaborated and approved by JMC on 11 May 2011. The Evaluation Plan defines and explains the overall co-ordination arrangements for the on-going evaluation process under the programme. Following the evaluation plan, the Programme is subject to three evaluations aiming to improve the quality, effectiveness and consistency of the assistance and the strategy and implementation of the Programme, taking due attention to sustainable development issues and horizontal objectives.

As result of the internal analyses of the output and result indicators in 2011, 2012 and 2013 performed by the MA, based on projects approved and the current progress in projects' implementation, several measures were implemented in view of improving Programme performance:

- Methodology for output and result indicators under the Programme was developed and uploaded to the Programme's web-page and recommendation for using the methodology during the preparation of project proposals was incorporated in the Guidelines for applicants under the third Call for Proposals.
- Risk assessment on a quarterly basis was carried out in order to take timely and adequate measures to mitigate and overcome any shortcomings during implementation of the subsidy contracts.
- In the Guidelines for Applicants for the third Call for Proposals there was an exhaustive list of eligible activities, to achieve concentration of resources to priorities, which were not sufficiently well addressed by the projects, funded under the first and second Calls for Proposals. The list of eligible activities was targeted according to indicators that were identified as underachieved, for example: eligible projects under the third Call for Proposals should have a focus on ICT and knowledge economy under Priority Axis 1 and a focus on protection and management of environment – under Priority Axis 2.
- An exhaustive analysis of the achievement and relevance of the Programme's output and result indicators, based on the implementation of the first and second call projects, was prepared by the on-going evaluation of the Programme in 2013. The Programme Annual Implementation Report for 2013 included both the main conclusions and recommendations of the Programme's mid-term evaluation and the values of the output and result indicators based on the finalised first and second





call projects. The final Programme's evaluation report as well as all the annual implementation reports are available at the Programme's website.

- Information on the physical and financial progress of the Priority Axis 1**

According to the revised financial plan for the period 2007-2013 funds available for Priority Axis 1 amounts to EUR 7 977 880 (out of which EUR 6 781 198 IPA funding and EUR 1 196 682 national co-financing).

The total number of projects contracted under Priority Axis 1 is 53, of which 17 are under the first call, 14 – under the second call and 22 – under the third call for proposals. All first and second call projects, and 8 third call projects have successfully finalised their activities by the end of 2014.

The financial implementation of the Priority Axis 1 projects until 31 December 2014 is 66% of the total contracting amounts or 87% of the Programme budget available for Priority Axis 1.

To assess the achievement, the sum of indicator's values for 2011, 2012, 2013 and 2014 was compared to 2016 target value. From the data in the table it is apparent that almost all targets for 2016 have been already considerably overachieved. Only one output indicator's value is little below its target for 2016, namely "Awareness campaigns of the benefits of ICT and new media" which is achieved at 83% and it is expected to be fully achieved after the second and third calls' projects are finalised.

➤ Sphere of intervention 1.2 "Social cohesion"

Objective of this sphere of intervention is to overcome the separating effect of the border and to promote correlation between the two sides. The activities in this sphere are aiming to contribute to the increase of social co-operation growth through strengthening connections and co-operation between different actors serving as a backbone to various cross-border initiatives.

The output indicators (OI) which are used to measure the progress under this sphere of intervention are shown in the table below. The information in the table is provided on the ground of successfully finalised projects. For 2013, the data are based on finalised first and second call projects and the indicators' values are presented as total number for 2013. Data on the forecasted achievement in 2015 and 2016 are based on the concluded and not finalised contracts under the second and third Calls for Proposals. To assess the achievement, the sum of indicators' values for 2011, 2012, 2013 and 2014 was compared to 2016 target value.

From the data in the table it is apparent that the majority of the targets for 2016 have been already overachieved, especially the indicators "People from vulnerable groups trained" (OI 7), "Training places created" (OI 2) and "Networking structures created / developed" (OI 9).

Some output indicators' values are expected to be achieved by the end of 2016, for example of the indicator "People participating in training" (OI 4). The expectations are that most of Programme's output indicators will be reached after the second and third calls' projects are finalised.

More efforts are needed for the targets of the following output indicators to be fully achieved, although they are reached between 64% and 77% (depicted ascending):

- Joint plans for co-operation in the sphere of human management (OI 10), achieved at 64%;
- People with enhanced skills (OI 5), achieved at 67%;
- Management and job-related training courses (OI 3), achieved at 77%;

Apparently the Programme is on good track for the achievement of its objectives. However, further efforts are needed for enhancing the co-operation for human resources development and management.

➤ Sphere of intervention 1.3 “Project preparation”

The objective of this sphere of intervention is to prepare mature projects to apply under other EU and national financial sources.

The output indicators which are used to measure the progress under this sphere of intervention are shown in the table below. The information in the table is provided on the ground of successfully finalised projects. For 2013, the data are based on first and second calls' projects, while for 2014, the indicators' values are based on the second and the third calls' projects. The expected indicators' values for 2015 and 2016 are provided based on projects contracted but not finalised yet.

The values of the result indicators for the years 2011, 2012, 2013 and 2014 are based on finalised projects. From the data in the table it is apparent that the beneficiaries have found more suitable to use the Programme support under this sphere of intervention for project environmental assessment, rather than for preparation of feasibility studies or preliminary and detailed works designs.

• Qualitative analysis

All first and second call projects, and 8 third call projects finalised their activities and the planned outputs were delivered. Envisaged activities were realised with the involvement of the target groups. Majority of the projects were based on balanced and adequate partnerships and demonstrated clear correlation between activities and results. There was a variety of activities financed under Priority Axis 1 which resulted in broad range of outputs.

Programme targets of outputs related to the objective for the development of business co-operation, clustering and networking were overachieved already by the first call's projects and delivered economic surveys, joint strategies and technical and business infrastructure rehabilitated.

Few projects under the first and second calls targeted the objective for boosting innovation and knowledge economy in the border region, and Programme's targets on indicators related to innovation were underachieved. For that reason, the list of eligible activities under the third Call for Proposals was designed to target knowledge economy and ICT. Overall, the supported first and second calls' projects created joint information services and business and educational linkages, having some contribution to innovation and knowledge economy.

From the data relating to output indicators of Spere of Intervention 1.1 it is apparent that all targets for 2016 have been already considerably overachieved with exception of the indicator "Awareness campaigns of the benefits of ICT and new media" which is expected to be fully achieved after the second and third calls' projects are finalised.

The Programme's targets on indicators related to human resources development are overachieved by the first call's projects only, though indicators are numerous. The majority of targets for 2016 output indicators of Spere of Intervention 1.2 have been already overachieved, especially the indicators "People from vulnerable groups trained", "Training places created" and "Networking structures created / developed". The objectives for integration of vulnerable groups were considerably overachieved.

The beneficiaries under Sphere of Intervention 1.3 have found more suitable to use the Programme support for project environmental assessment, rather than for preparation of feasibility studies or preliminary and detailed works designs. Apparently the Programme is on good track for the achievement of its objectives for Priority Axis 1.

3.1.2. Significant problems encountered and measures taken to overcome them

No significant problems were encountered in 2014.

3.2.1. Achievement of targets and analysis of the progress

- **Information on the physical and financial progress of the Priority Axis 2**

According to the revised financial plan for the period 2007-2013 funds available for Priority Axis 2 amounted to EUR 9 972 348 (incl. EUR 8 476 497 Community funding and EUR 1 495 85 national funding).

The total number of projects contracted under Priority Axis 2 is 47, of which 18 are under the first call, 18 – under the second call and 14 – under the third call for proposals. All first and 15 second call projects, and 2 third call projects have successfully finalised their activities by the end of 2014.

The financial implementation of the Priority Axis 2 projects until 31 December 2014 is 69% of the total contracting amounts or 76% of the Programme budget available for Priority Axis 2.

Data for the expected achievement in 2015 and 2016 is based on the implemented and not finalised contracts under the second and third Calls for Proposals. To assess the achievement, the sum of indicator's values for 2011, 2012, 2013 and 2014 was compared to 2016 target value.

From the data in the table it is apparent that the majority of the targets for 2016 have been already overachieved, especially the indicators “Partnerships for cases of natural disasters established” (OI 4) and “Permanent networks for environmental protection and reasonable utilisation of resources” (OI 6).

The expectations are that most of Programme’s output indicators will be reached after second and third calls’ projects are finalised, although some more efforts are needed for the targets of the following output indicators to be fully achieved:

- Joint environmental management plans (OI 5), achieved at 47%;
- Joint tourist services created / developed (OI 3), achieved at 71%;

As a whole, the Programme is on good track for the achievement of its objectives. Obviously, indicators targets set have been very ambitious in spheres like joint nature / environment management plans development and joint tourism products.

➤ Sphere of Intervention 2.2 “Utilisation of cultural resources”

The objective of this sphere of intervention is to foster the cross-border co-operation in the field of cultural affairs and thus contribute to the improvement of quality of life in the region. The development of cultural tourism potential will also lead to a reasonable and sustainable use of the opportunities of the region.

To assess the achievement, the sum of indicator's values for 2011, 2012, 2013 and 2014 was compared to 2016 target value.

From the data in the table it is apparent that the majority of the targets for 2016 have been already overachieved, especially the indicators "Joint cultural events carried out" (OI 5) and "Events popularising intangible cultural heritage and traditions" (OI 6).

The expectations are that most of the Programme output indicators will be reached after second and third calls' projects are finalised, for example the indicator "Tourist services created / developed" (OI 3). Even the indicator "Number of projects concerning common cultural heritage" (OI 1) is achieved at 63% of its target value for 2016, which is a good sign that the Programme gives opportunity to the region to implement projects that would have never be implemented without its financial support.

- Qualitative analysis**

All projects under Priority Axis 2 have a clear correlation between activities and results. They address mainly the investment needs of the Programme area. The projects have not had serious implementation problems threatening the achievement of project results.

The objective for eco, rural and cultural tourism development was addressed by several projects (mainly investment projects) which contributed to improvement of tourism attractiveness of the region by reconstruction of museums, construction of centres for interpretation of cultural heritage, improvement of surrounding of the cultural sites and their accessibility. These projects contributed as well to the development of tourism services and joint cultural and awareness events. By the end of 2014, all programme output indicators related to tourism development were achieved by the implementation of the projects under the three Calls for Proposals.

The objective for cultural co-operation strengthening was targeted by several projects, both investment referring to cultural infrastructure improvements and soft ones. Apart from the investment components, under the supported projects a number of joint cultural events were conducted (concerts, planners, festivals, music and theatre performances, exhibition, etc.). All projects implemented under Priority Axis 2 are expected to deliver their planned outputs. The projects have clear contribution to improving the access of people in the cross-border region to cultural services.

From the data relating to output indicators of Spere of Intervention 2.1 it is apparent that the majority of the targets for 2016 have been already overachieved, especially those relating with the response to natural disasters, environmental protection and reasonable utilisation of resources. As a whole, the Programme is on good track for the achievement of its objectives, despite some targets have been too ambitious in spheres like joint nature / environment management and joint tourism products development.

The target for implementing projects concerning common cultural heritage was achieved at 63%, which is a good sign that the Programme gives opportunity to the region to implement projects that would have never be implemented without its financial support and promotes the cross-border cooperation in a proper way.

3.2.2. Significant problems encountered and measures taken to overcome them

No significant problems were encountered in 2014.

Not applicable – no major projects were financed under the Programme.

5. TECHNICAL ASSISTANCE

The purpose of „Technical Assistance“ (TA) Priority Axis is to ensure an effective and efficient programme management and information flow, thus improving the quality of cross-border co-operation and management

tools. The TA Priority Axis finance the preparatory, management, monitoring, evaluation, information and control activities of the programme as well as activities to reinforce the administrative capacity for implementing the programme, promotion of the Programme, awareness raising, pro-active project generation, etc.

- **Sphere of Intervention 3.1 “Overall administration and evaluation of the programme”**

The objective of this sphere of intervention ensures:

- Support to the MA and JTS for tasks related to preparation of the necessary documents, appraisal and selection of projects, monitoring and evaluation of activities, control and audit of the Programme including daily allowances, travel accommodation costs covering the expenses for the participants from both countries (representatives of the MA, JTS, CA, AA, JMC, persons who are not directly involved, for example interpreters, drivers etc.) in events concerning the programme.
- Determine administrative costs concerning the JTS (main and branch offices) including rent of premises, repair works furniture and equipment, expenditures for electricity, heating, phones, water, consumables etc. and also staff remuneration costs for the JTS (main and branch offices).

A significant problem was detected during 2014 concerning considerable delays in the payments of the remuneration costs of the staff of the JTS branch office in Strumica. This situation has led to serious difficulties in the daily work of the experts and in particular in the process of monitoring of the projects. The problem has been taken into consideration by the responsible authorities.

- **Sphere of Intervention 3.2 “Publicity and communication”**

The objective of this sphere of intervention ensures:

- Preparation, translation and dissemination of the Programme related information and publicity materials including but not limited to the programme website, official Programme documents, procedure manuals, bulletins, brochures, posters, etc.; as well as expenses for consumables as paper, files, folders, cases, diskettes, compact disks, etc.
- Organisation of public events as conferences, seminars, workshops, round table discussions, training for beneficiaries, networking and awareness-raising events, partner search forums etc. including rent of halls and equipment (audio-, video-, translation equipment), expenses for interpreters, lecturers, trainers (should not be persons involved in the programme); expenses for coffee breaks, refreshments, business diners and lunches for all participants in the events;

- Purchase of advertising materials, such as CDs, USBs, hats, bags, note books, folders etc. as well as expenses for publications on media: radio, TV and press.

For the period 2007-2013 amount of EUR 1 695 299 Community funding is available for the “Technical assistance” Priority Axis.

In order to implement the activities under „Technical assistance“ Priority Axis, an Annual technical assistance plan is prepared by the MA, together with the other structures involved in the Programme implementation. The Annual Technical Assistance Plan is designed to provide detailed information about the Programme related activities envisaged to be carried out by the Managing Authority (MA), the National Authority (NA) and the Joint Technical Secretariat (JTS) under „Technical assistance“ Priority Axis and is subject of approval by the JMC.

Total budget forecast for 2014 was amounted to EUR 537 255, of which EUR 324 855 allocated for MA and EUR 212 400 for NA. The detailed indicative breakdown of budget for 2014 was approved by JMC on 15 January 2014.

The 2014 TA budget encompasses administrative expenditures, travel and accommodation expenditures, meetings, training sessions, promotional events, information and publicity, external expertise, supply, maintenance of equipment and other expenditures.

The main activities carried out under“Technical Assistance” Priority Axis within 2014 are as follows:

- **Organisation of public events as conferences, seminars, workshops**

Information days / Regional consultative fora

Two rounds of regional consultative fora were organised in the border region in the framework of the service contract for Preparation of the IPA II Cross-border Co-operation Programme. The first round of consultations was held in February – March 2014 in the towns of Strumica, Stip, Kumanovo, Kyustendil and Blagoevgrad with 182 participants. Findings of the SWOT analysis and the territorial analysis were presented and discussed, and the expectations related to the future co-operation programme were explored. During the second round a joint regional consultative forum on the draft Programme strategy with 52 participants was held In June 2014 in Strumica. The draft investment strategy of the programme within the selected by the Programme joint working group thematic priorities was presented. The stakeholders gave their input in terms of specific objectives, results, examples of activities as well as the prospective types of beneficiaries. Reports from the on-line survey conducted in February 2014 with 142 respondents as a first step in the programming consultative process, and from the two rounds of regional consultative fora were published on the Programme website and also communicated to the joint working group members.

European Co-operation Day

For celebration of the European Co-operation Day Joint Technical Secretariat organised two events under the motto "Sharing borders, growing closer!" which were held on 17 September 2014 in Blagoevgrad (Bulgaria) and on 18 September 2014 in Stip (former Yugoslav Republic of Macedonia). The celebration of European Co-operation Day consisted of exhibition of photographs entitled "The beauty of the cross-border region" in the hall of the municipality of Blagoevgrad and Art Gallery "Bezisten" in Stip and pop-rock concerts "Sharing borders, growing closer!" in "Makedonia" square in Blagoevgrad and the small square in Stip, which was held on 17 and 18 September in Blagoevgrad and Stip.

Project implementation training

Three training sessions for Bulgarian and Macedonian beneficiaries on the implementation of additionally funded projects under the third Call were held during 2014 (two at the premises of JTS Kyustendil and one in Strumica).

Four training sessions for project teams of the financed under third Call for proposals have been organized during 2014.

Programme staff training

During 2014, MA, NA and JTS staff attended training events organised by INTERACT Programme in order to acquire practical knowledge and information, to share their experience with colleagues from other European territorial cooperation programmes in the field of management techniques, financial issues, European regulations, communication, strategic orientation, policy development, etc.

• Expenditures for external expertise

Throughout 2014 the technical assistance budget was used for remuneration of external independent controllers, for maintenance and upgrade of the Programme website and maintenance of MIS.

The main activities for preparation of Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme 2014 – 2020 were implemented in 2014. The Programme preparation was supported by the planning team of the Project Planning and Management Consortium under a service contract financed by the Technical Assistance Priority Axis with duration of seven months. The contract was concluded between the Managing authority and PPM Consortium on 28 November 2013 and extended by two months with an addendum signed on 31 May 2014. The total contract's amount remained unchanged – EUR 68 500, and the final payment of EUR 27 400 was made in 2014 after the successful project's accomplishment.

In May 2014 a service contract for Ex-ante evaluation and Strategic Environmental Assessment of the IPA

CBC Programme Bulgaria – the former Yugoslav Republic of Macedonia IPA Cross-border Programme was concluded between the Managing authority and Lattanzio e Associati S.p.A., Italy. The project's duration was four months and its main objectives were: to improve the quality of programme design and to ensure that the draft IPA II CBC Programme clearly articulates the intervention logic and that it contributes to the Europe 2020 strategy and the relevant macro-regional strategies; to perform Strategic Environmental Assessment of the draft Programme and to ensure that the environmental considerations have been taken into account in the final draft of the Programme before its submission to the EC for approval. As per the service contract, the contract's amount of EUR 42 980 was transferred to the Contractor in two instalments – an advance payment of 40% and a final payment of 60% of the contract's budget.

Another service contract with subject "Development of methodological guidelines for baseline and indicative target values establishment of qualitative result indicators under IPA II CBC Programmes 2014-2020 between Republic of Bulgaria and EU External Borders' Partnering Countries" was concluded between the Managing Authority and Sigma Hat Ltd., Bulgaria, on 12 September 2014. Initially, the contract's duration was four months but after the draft IPA II CBC Programme's submission (in September 2014) it was extended to twelve months. The reason of this extension was that the negotiations with the EC were likely to lead to certain changes in the Programme intervention logic, hence – they would influence the Programme result indicators as well. The project purpose is to elaborate methodological guidelines for baseline and target values establishment concerning qualitative result indicators under IPA II CBC Programmes 2014-2020 between Republic of Bulgaria and EU External Borders' Partnering Countries – Turkey, former Yugoslav Republic of Macedonia. Methodological guidelines on how to use the tools to measure result indicator's baselines and values will be provided by the Contractor and training sessions for the Managing authority and the three Joint secretariats will be organised after the Programme approval.

- **Programming for the period 2014-2020**

The drafting of the IPA II Cross-border Co-operation Programme Bulgaria – the former Yugoslav Republic of Macedonia was organised in compliance with the partnership approach as referred to in Article 5 of Regulation (EU) No 1303/2013. "Territorial cooperation management" Directorate General at the Ministry of Regional Development and Public Works of the Republic of Bulgaria, designated as Programme's managing Authority, co-ordinated the process together with Joint Secretariat support.

Maintaining a broad partnership was a guiding principle during the entire programming process. The Joint Working Group (JWG), established in November 2013 continued working in partnership and kept on preserving the balanced representation of the public authorities (national, regional and local), economic and social partners, relevant bodies representing civil society, including environmental partners, non-governmental organisations, and bodies responsible for promoting social inclusion, gender equality and non-





ANNUAL IMPLEMENTATION REPORT 2014

discrimination as rules of conduct guiding the Programme development process and was approving the main stages of Programme elaboration. A Task Force (TF) for discussing particular topics and draft proposals, also established in November 2013, stayed operational.

The OP was developed in an iterative, consultative process and the involvement of stakeholders was organised in several stages:

- An on-line survey among national and regional stakeholders was conducted in February 2014 with 142 respondents as a first step in the programming consultative process. The survey aimed also at gathering the respondents' expectations related to the scope, the content and other important aspects of the programme, as well as their preferences for thematic priorities for co-operation for the 2014-2020 period. It helped to identify specific demands and expectations towards the new programme among potential target groups.
- Two rounds of regional consultative forums were organised. The first round was held in February – March 2014 in the towns of Strumica, Stip, Kumanovo, Kyustendil and Blagoevgrad with 182 participants. Findings of the SWOT and the territorial analysis were presented and discussed, and the expectations related to the Programme under elaboration were explored. During the second round a joint regional consultative forum on the draft Programme strategy with 52 participants was held In June 2014 in Strumica. The draft investment strategy of the programme within the selected by the JWG thematic priorities was presented. The stakeholders gave their input in terms of specific objectives, results, examples of activities as well as the prospective types of beneficiaries. Reports from the on-line survey and the two rounds of regional consultative forums were published on the Programme website and also communicated to the JWG members.
- Reports from the on-line survey and the two rounds of regional consultations were published on the Programme website and also communicated to the JWG members.
- Relevant draft programme documents and publications as well as information on the programming process have been published regularly on the Programme's website.
- The draft Programme and the Strategic Environmental Assessment report were made available for public consultations on the Programme website, the websites of the Managing and National Authorities, the environmental authorities in Bulgaria and the former Yugoslav Republic of Macedonia and considerable feedback was received and integrated into the draft Programme where appropriate.

The final draft Programme was elaborated according to inputs from the Joint Working Group and from regional and local stakeholders, including environmental authorities, thus ensuring the ownership of planned interventions by stakeholders and building on the experience and know-how of relevant actors.

Two JWG meetings (in Skopje and in Sofia) were held in 2014 with the financial support from the TA budget.

The draft final IPA II Cross-border Co-operation Programme Bulgaria – the former Yugoslav Republic of Macedonia was approved by the governments of the two partnering countries and the JWG, and was sent to the European Commission on 19 September 2014 for approval.

A technical meeting with the participation of the Managing Authority, National Authority and Joint Secretariat was held on 9 December 2014 in Sofia, where the management and control system and the first draft of the Memorandum of Understanding for the period 2014-2020 were presented. Issues related to the new programming period were discussed, as well as the status of projects' implementation under the programming period 2007-2013 was presented.

After EC official comments were received on 3 February 2015, the revised draft (version 2.0 of March 2015) of the Programme was re-submitted for approval to the Commission on 6 March 2015.

6. INFORMATION AND PUBLICITY

The focus of the information and publicity strategy is centred on increasing the awareness and promoting the positive work of the Programme. For the purposes of implementation of the information and publicity strategy, a detailed Communication Plan is elaborated and approved simultaneously with programme approval. The aim of the Communication Plan is to ensure broad dissemination of the information about the programme, to guarantee the transparency of the programme's implementation and to increase the awareness of the local stakeholders about the programme's possibilities. The implementation of the Communication plan is responsibility of the Managing Authority, National Authority and JTS.

During 2014 variety of activities included in the Communication plan have been organised and performed in order to reach out to a wide audience, e.g. media events, regional consultations, training for beneficiaries have been successfully organised; various types of promotional materials have been produced and disseminated to the target audience, the Programme Web site has been redesigned and maintained, etc. For further evidence on this topic, please refer to Annex A.

The manual is a comprehensive collection of rules, recommendations and best practices from a variety of sources, and is strictly in line with "Communication and Visibility Manual for European Union External Actions" of EC and the basic "Project Implementation Manual" rules.

- **European Co-operation Day**

For celebration of the European Cooperation Day, the Joint Technical Secretariat organised events in Kyustendil on 17 September 2014 and in Stip on 18 September 2014. Both events included:

Photography exhibition entitled "The beauty of the cross-border region" in the hall of the municipality of Blagoevgrad and Art Gallery Bezisten in Stip and

Pop-rock concerts "Sharing borders, growing closer!" in "Makedonia" square in Blagoevgrad and the Small Square in Stip, with participation of the youth groups from Bulgaria and the former Yugoslav Republic of Macedonia – winners of contest for best song of the cross-border region.

Photos for the competition were accepted from 28 July 2014 to 5 September 2014 and 400 photographs of over 40 participants from all over Europe were obtained. The jury selected 45 photographs that were part of the exhibition "The beauty of the cross-border region" and determined the first three places. The audience had the opportunity through Facebook page and Programme website to choose one photo.

The pop-rock concerts "Sharing borders, growing closer!" took place in square "Makedonia" in Blagoevgrad from 20:00 h. and in the Small Square in Stip where the winners of a contest for the best song of the cross-border region - youth groups from Bulgaria and the former Yugoslav Republic of Macedonia, took part.

In addition to the promotion through the Programme website and the websites of the official institutions directly related to the Programme, both the Programme and the projects funded received a good deal of media attention through specific Programme press-releases (in all the three languages), online publications (other than on the Programme website), radio advertisements, video and television clips, publicities in local and national newspapers.

- **Project implementation training**

Four training sessions for the project teams of the third Call for Proposals projects were organised by the JTS and they took place, as follow:

23 January 2014 in Kyustendil – for the projects contracted in 2013;

21 May 2014 in Kyustendil – for the beneficiaries whose projects were additionally contracted under the third Call for Proposals;

11 September 2014 in Kyustendil – for Bulgarian beneficiaries whose projects were additionally funded;

11 September 2014 in Strumica (the former Yugoslav Republic of Macedonia) – for Macedonian beneficiaries whose projects were additionally funded.

All project teams were trained on all the aspects of project implementation, when the main topics were:

- Financial and technical implementation of the financed projects, including project's progress and financial reporting;
- Contract modifications;
- Sub-contracting procedures;
- Financial implementation and irregularities;
- Visualisation and other relevant issues.

During 2014 variety of activities included in the Communication plan have been organised and performed accordingly: various types of promotional materials have been disseminated to the target audience, the Programme Web site has been redesigned and maintained, and training sessions for beneficiaries have been successfully organized. The mass media campaign and the participation of different events greatly contributed to the successful promotion of Programme and the Call for proposals. The Programme's visual identity and graphics standards have been maintained and widely disseminated to all the Programme's stakeholders.

- **Regional Consultative Fora for the preparation of the IPA II Cross-border Co-operation Programme**

Five Regional Consultative Fora took place between 26 February and 7 March 2014 in the district centers of the cross-border area in the framework of preparation of the IPA II Cross-border Co-operation Programme. The meetings were held as plenary discussions with the aim to:

- Inform regional stakeholders about the ongoing programming process for the IPA II cross-border programme and the external experts' findings on regional analysis and identified needs;
- Present and discuss a possible prioritisation of thematic priorities for the future cross-border programme;
- Discuss potential actions that may be relevant for addressing the identified needs and challenges in the respective thematic priority areas.

The regional consultations started in Strumica on 26 February 2014 at the Sirius Hotel with 30 participants from the Southeastern Statistical Region, the former Yugoslav Republic of Macedonia.

The second Regional Consultative Forum was held on 27 February 2014 in Stip in hotel Oaza. This forum was attended by over 50 representatives of stakeholders from the Eastern Statistical Region of the former Yugoslav Republic of Macedonia.

Third Regional Consultative Forum was held in Kumanovo on 28 February 2014 in NAMA Restaurant. This forum was attended by over 40 representatives of local governments, schools, non-governmental sector from the Northeastern Statistical Region of the former Yugoslav Republic of Macedonia.

On 6 March 2014 the Joint Technical Secretariat in Kyustendil hosted the first Regional Consultative Forum in Bulgaria. 30 representatives of stakeholders from Kyustendil District were acquainted with the results of the analysis and IPA II thematic priorities for cooperation.

The first round of regional consultations ended in Blagoevgrad, where on 7 March 2014 at Ezerets Hotel the last meeting was held, attended by over 30 representatives of public / local governments, NGOs and media from Blagoevgrad District as well as representatives from several municipalities in the former Yugoslav Republic of Macedonia.

The second round of regional consultations took place on 4 June 2014 at the Sirius Hotel, Strumica, with over 60 representatives of the two countries.

- **Joint Working Group for preparation of the IPA II CBC Programme**

On 23 April 2014 in Skopje the Joint Working Group (JWG) for preparation of IPA II Cross-border Co-operation Programme 2014 – 2020 held its second meeting.

The main topic on the agenda was the presentation of the programme strategy and review and approval of the thematic priorities.

The final meeting of the Joint Working Group for preparation of IPA Cross-border Co-operation Programme 2014-2020 took place on 21 August 2014 at “Best Western City Hotel”, Sofia, Bulgaria. The JWG session was aimed at the finalisation and approval of the Programme document.

The meeting was attended by the majority of members of the Joint Task Force. After detailed presentation and a discussion the final draft of IPA Cross-border Co-operation Programme 2014-2020 document was approved unanimously.

- **Media campaign**

Media campaigns and the participation in different events greatly contributed to the successful promotion of the Programme and the Call for Proposals. The Programme's visual identity and graphics standards have been maintained and widely disseminated to all the Programme's stakeholders. More details can be found in Annex A attached to this report.



Culinary traditions:
The number of painted eggs on Easter depends on the number of family members, while in some villages, it depends on the number of the hens. Tradition says that painting should be made on Thursday morning before Easter and it is priority of the oldest woman in the family, while young girls and brides make the eggs decoration. In the past, the first red egg was carried in the church (to protect from harm).
There were red symbolizing the Resurrection, but other colors and combinations were also used. In older times, eggs were painted with the help of boiled herbs, with natural bright and pure colors: red (with oregano), orange-red (with sticks of saffron), green (nettles), yellow (with nuts and apple peels). People used for dyes also Polish elderberry, red onion, geranium, etc. Besides for family members, eggs are painted also for sponsors, for children and guests. For them, the eggs are decorated with drawings, geometric shapes, with petals, decoupage, wax, etc. Such eggs are called "parashki" (painted eggs). With the first painted red egg, women used to rub the faces of children for health.
On Thursday before Easter, the sourdough should be renewed and with it are prepared ritual loaves of bread, which could be round, triangular or braided. In the past, there were especially compactly prepared for the Easter, with the participation of the whole family, for making over the festive table. Before baking the braided ritual loaves of bread, 3 eggs were placed on them - one white and 4 red. The newlyweds carried painted eggs and ritual bread to the godparents and parents of the bride in Sunday morning, i.e. on the first day of Easter.
On Easter, people knead sweet bread, called in Bulgaria "kozunak". The story of "kozunak" begins from more than 3 centuries. In the beginning of XVII century, a French baker knaded the original of today's Easter cake. It was served on the table on the first day of Easter in the city of Plovdiv, Bulgaria, "kozunak" is prepared since 1900, firstly in cities. Along with it, city housewives prepared cake with 14 eggs. In the past, when the "kozunak" was not widespread, women made butter sweets. On the Easter table are served mainly foods of animal origin, because the holiday puts an end of the Lent.
The menu compounds compulsorily of lamb meat with green spices, oddments, lamb trifles soup, eggs, cheese, milk, kozunak, butter sweets, red wine. In the past, people roasted lamb for Easter with "bumba" (the lamb's belly, filled with rice and vegetables) in a clay oven, while from intestines they made "kuikuri" (the lamb intestines are being fried and roasted on embers).



The project also presents organic agriculture as a method which contributes towards sustainability in terms of water management, soil management, waste reduction and the protection of biodiversity. It proposes raising awareness and development of capacity building measures for self- improvement of the organic producers' knowledge and skills in a form of Organic Production Know – How Packages for beginners and advanced organic producers and Organic production manuals for improvement of knowledge of advisory, training and educational service providers. It also proposes establishment of relations for joint cooperation, exchange of ideas, experiences and good practices among organic production stakeholders of both sides of the border, thus utilization of the given information in regards to bringing the organic agriculture as sustainable and effective agriculture model in favor of both local communities and environment.</p>
